Currumbin Honors Its Fighting Men

A glowing tribute to the valor and efficiency of Australian Navy, Army and Air Force personnel was paid by Mr R. E. Court, president of Currumbin and District R.S.L. Sub-Branch, at the unveiling of an honor roll at Currumbin Memorial Hall on Sunday last.

He described the men of the RAAF as being virile, brave beyoud measure, intellectual and intelligent and the cream of Australia's manhood.

Between 250 and 300 people attended the function, coming from all parts of the South Coast and Brisbane.

Mr Court, who was chairman, welcomed the official visitors, who included the Deputy-Mayor, Ald E. M. Budd, and members of Coolangatta Town Council, Cr J. Schuster, representing Nerang Shire Council, Messrs E. V. Rosenberg, senior vice-president of the South-Eastern Division, C. A. Milne and E. "Skip" Rees, RSS and AILA, H. G. Winders, president of Tweed Heads and Coolangatta sub-branch, and Mr and Mrs S. W. Winders, representing the patriotic organisations of Coolangatta.

The honor roll, which occupies a prominent position on the wall of the hall, has on it the names of 112 service personnel, including six women, who enlisted from the Currumbin, Currumbin Creek, Tugun and Palm Beach districts in the 1939-1945 war.

Following Mr Court's address, those present observed a minute's silence in respect for fallen comrades and at the conclusion of the unveiling the Last Post and Reveille were sounded by Bugler Ford. The hym "Abide With Me" was sung.

Mr Winders said his committee intended, with the permission of the Coolangatta Town Council, to assist the Currumbin sub-branch in improving its memorial hall and park to make them a fitting memorial in honor of those who fought and those who died.

Mr L. Mitchell, a grandson of Mr and Mrs Peter Mitchell senr, two of Currumbin's oldest citizens, then unveiled an honor board erected by the sub-branch in appreciation of the work of the Currumbin Patriotic Guild, an enthusiastic body which cared for the comfort of the men and women of the forces during the

Response was made by Mrs W. Ewers, president of the Guild.

At the conclusion of the ceremony, those present were entertained at a light lunchers by the members of the sub-branch Women's Auxiliary.
