In further reference to my letter of the 18th November last and your reply of the 13th. November, I have the honour to inform Your Excellency that I am in receipt of a further letter from the Trustees of the Indooroopilly Memorial Church asking if the Commonwealth Authorities are willing to allow them to retain the title of "Anzac Memorial Church" for their new building.

The following are relevant extracts from the Trustees' letter just received:-

"The Trustees of the new church (Methodist) at Indooroopilly, through Rev. A. Hutchison, asked for permission to call their church "The Anzac Memorial Church". They received a reply, dated Nov. 1st 1916, stating that their application was being forwarded to His Excellency the Governor General, with His Excellency's endorsement. We have gone on the strength of this letter up till now, and the name "Anzac Memorial Church" is on the foundation stone laid by His Excellency. We propose to formally open the building on Saturday September 1st, and are desirous of an assurance that we have the right to continue to call it by that name. I may add that the building will be a worthy memorial of the heroes to whom it is dedicated, being well built of brick and tiles, roomy and handsome. There will also be memorial windows and an Honour Board in memory of fallen and other Anzacs, who went from this district."
